# False Complaints Gets FOBB Booth Removed From Avocado Festival

By any measure, Friday, October 6, was a very successful day for Friends of Bates Beach at its Avocado Festival booth in Carpinteria. Our new location in the high-traffic area brought us many visitors, almost all supportive and enthusiastic about our being there, and we collected nearly 300 names and emails from our raffle. (see story on page 2).

During that Friday, we met many enthusiastic visitors, some of whom had visited the beach when they were younger, and we shared happy memories. We said hello to several members of the city council who came by the booth, and Supervisor William's Field Deputy Spencer Brandt also dropped by to say he approved of the way we were running our booth. I also made sure to say hello to other civic leaders and council members who were present during the afternoon's opening ceremonies.

But there are always a few complainers who ask out loud why we were allowed to be there. This is a normal occurrence and as a rule, we never engage with them as their minds are already made up. We didn't expect a couple of them to take their anger to the next level.

At about 4:30 PM a sheriff's deputy motioned me out of the booth to talk. I walked across the street to meet him, and he said our booth had received a complaint that we were soliciting minors as I and others were seen answering questions from teens about the beach. The complaint was about me, personally, as I had talked to a teenage girl who spun the wheel and asked about the beach. I strongly disagreed with the complainer and invited him to watch the booth operations for himself. He did so for several minutes and suggested we not talk to anyone about the beach who was not an adult, that we could have kids spin the wheel for a prize, but don't engage them in conversation, only their parents. I agreed and returned to the booth and informed the staff of the conversation and the suggestion. When I got home that evening, I emailed all of the Saturday volunteers about not speaking to teenagers about the beach unless their parents were standing right there and giving permission. I thought that was the end of it.

Then came 7:30 AM the following morning. I was awoken by a phone call from the Festival director, Olivia Sorgman, that she had received two complaints that we were soliciting minors because we allowed them to spin our prize wheel. I told her we always asked everyone – all ages – who walked by to spin the wheel and win a small prize.

We had already been visited by the officer the night before and had made changes to how we operated the prize wheel. Sorgman didn't care.

She said our booth was being removed from the show at that moment, our contents packed up and placed on the sidewalk, (see photo) and can we please come and pick them up? There was no discussion, no explanation allowed, we were just out.

This after five years of being in the Festival, always working our booth the same way, without any complaints.

Obviously, these two complainers saw what they wanted to see and heard what they wanted to hear, and they strongly disagreed with the subject of us promoting the nearby clothing-optional beach.

So we missed the last two days of the Avocado Festival. Are we angry at being labeled something we are not? Of course! But there was little we could do about it at the time.

Our team was pretty shaken up at this news, as you can imagine. I told them that the more visible we became the more our opponents would come out of the woodwork, and we need to be prepared for more pushback in the future.

On October 15, I wrote a strong but constructive letter to the Festival organizers that we are an ongoing part of the community, and we will find another way to get our positive message out to our friends in the local business community. I also demanded a refund of all booth fees (about \$800). We have not heard a reply yet. We have contacted an attorney in case we need to go to small claims court. The truth is legally there is nothing else we can do about it, although going to court virtually guarantees we will never be asked back.

I was relieved that no letter to the editor appeared in subsequent issues of *The Coastal View*, the local town newspaper. The story seems to have faded into "yesterday's news.

Emails were sent to Bob Morton, the former Exec Dir of the Naturist Action Committee, and Stuart Brandt at Supervisor Williams' office.

Morton replied that he suspected we were set up. "There's no other reason to believe that two obviously antagonistic biddies would station themselves so close to your booth that they would overhear a personal conversation. Likewise, there's no other reason that the festival organizers would have acted so quickly, precipitously, and irreversibly. The fix was in."

Brandt wrote that he was sorry to hear of this incident but "appreciate you keeping me informed."

The leftover giveaway items we had planned to give away at the booth wheel will be slowly distributed through the following year at the beach and at other FOBB meetings and parties.

# Avocado Festival Survey Showed Strong Support For Nude Recreation

Each year since 2017, we traditionally do an informal survey at our AvoFest booth of our visitors asking their opinion about having an official clothing-optional beach nearby and a second question about top freedom in general.

The results have always been positive, averaging 75% "Yes" most years for the beach, and hovering just under 50% for top-freedom.

Although our booth was only up for one day and our total visitor count was about half its normal sample (154 votes this year compared to 234 votes in 2022), the results were much more positive this year:

Results of our two-question survey:

1. Santa Barbara County should designate a section of beach for **clothing-optional recreation**. The beach should have **proper signage** so people can decide whether to go there or not.

I agree (Yes) 84% I do not agree 8% No opinion 8%

2. Women should be allowed to be top-free wherever men are allowed to do so.

I agree (Yes) 56%

The results showed a remarkable increase in the "Yes" vote after 5:30 PM, where the mostly younger "date night" crowd voted 93% "Yes" for the clothing-optional beach and 70% Yes on the Top Freedom question.

As always, these results will be forwarded to the Carpinteria City Council and the County Board of Supervisors to demonstrate our positive community support for our cause.

### Mid-Week Bates Beach Outings Come To An End, Maybe

### Carp Council Member Roy Lee Will Challenge Supervisor Williams In 2024

Two supporters of Bates Beach will be squaring off against each other in March 2024 for the County Supervisor seat whose district includes Carpinteria and Bates Beach.

Roy Lee, owner of the popular Uncle Chen Chinese restaurant in Carpinteria and a second-term member of the Carpinteria City Council, is challenging two-term County Supervisor Das Williams for his seat.

My preliminary assessment of the race is that Williams is vulnerable this time because he approved of a large number of cannabis-growing farms in northern Carpinteria, near the town's high school. Other zoning decisions converting nearby farmland to lowercost housing have also made many residents angry.





Councilmember Lee also dropped by the Festival booth on Friday and said he wanted to talk to us about his campaign.

Our conversations with both candidates will continue as the election season approaches.

### OTHER IMPORTANT NUDIST STORIES

To our readers: Besides our setback at the Avocado Festival this month, there were several other important news events in October that rocked the nudist community. The following pages reveal that we can never take our way of life for granted.

Following the changeover at De Anza outside San Diego in September from nudist-friendly to textile-only, and the August announcement that the Two Roads Theater where we enjoyed the Nude Comedy shows during the past six years is up for sale, we were surprised to hear that California might lose two additional nudist-friendly resorts. The fast-moving events in Wisconsin remind us that there are always people lurking in the shadows ready to shut it down based on their own prejudices and ambitious politicians ready to use social nudity as a wedge issue to gain votes for themselves.



## Palm Springs Desert Sun Resort Is In Escrow To Private Buyer

10/24/23 - In yet another significant development that could bring further changes to California's naturist community, Desert Sun Resort in Palm Springs has been sold for \$6,950,000 and is currently under contract, as indicated in public listings on Redfin.com and LoopNet. The specific details about the new owners and their plans remain undisclosed.

No public announcement has been made by the club on their website or social media. This sale adds to an expanding series of recent transformations in the state's nudist landscape, and a growing malaise among California naturists, who have seen no less than four nudist clubs either go textile or go up for sale just in the last three months.

When Planet Nude called the Desert Sun Resort seeking comment, the unnamed voice on the other end confirmed that the property had indeed been sold and was currently in escrow. However, they couldn't provide any information about the new owners or their intentions regarding the resort's clothing-optional status.

[Editor's note: The resort is not accepting any new reservations after December 31 and there will be no New Year's Eve party.]

The description provided in the listing does offer some insight. Notably, the description suggests that the property could be "converted to a traditional hotel" with "additional options for increased revenue." This reference to a potential shift towards a clothed hotel raises questions about the fate of clothing-optional experiences at the Desert Sun Resort, leaving naturists eager to see how this story unfolds.

#### **DESERT SUN HISTORY**

Desert Sun Resort has a storied history that has been a notable part of the Southern California naturist community for more than thirty years. Originally established in 1992 as the eleven-room Desert Shadows Inn, the resort rapidly expanded to take up nine full acres in just eight years and became for a time the number-one nudist resort on the West Coast.

The club underwent a significant transformation when John and Elizabeth Young purchased the property in 2008. There was a million-dollar remodel of all hotel rooms, pools, Jacuzzis, the restaurant, and spa facilities. However, the new ownership instituted a "no minors" policy, making them the only non-sexual nude resort in Southern California to allow only people over the age of eighteen into the club.

One iconic feature of the resort is the Lee R. Baxandall Bridge, affectionately referred to as the "naked bridge" or "Bridge of Thighs." This distinctive pedestrian bridge was built in 2003 and was designed to conceal the unclothed pedestrians who crossed it from the drivers busy passing on Indian Canyon Drive below. The bridge was named in honor of The Naturist Society founder Lee Baxandall and became a symbol of the resort, offering a unique gateway to guests, visitors, and residents, and adding a distinguishing feature to the city and community of Palm Springs.

### More About the Desert Sun Sale

On 10/25/23, I telephoned friends who live in the nude condos across the street from Desert Sun, and they said the following:

A group of 10 nudist condos were built by Steve Payne, a previous owner of the resort, on the west side of Indian Canyon Dive for nudists wanting to live adjacent to the resort. The bridge was built to connect them to the resort. After ownership changed, it was fenced off a few years later when the Desert Sun's owner learned the bridge was not technically part of his property. Instead, the condo owners were given easement and membership rights to the resort.

The condo owners reorganized as the Desert Shadows Condo Association (DSCA), and they voted to keep their area "nudist only" in its common areas (pool, clubhouse, etc.), not "clothing-optional." To this day, these areas are only open to their condo members and their guests and not to the general public.

In January 2023, the DSCA received a letter stating they would be officially separated from Desert Sun effective June 1 with access rights further restricted. Memberships in Desert Sun by any condo members will not be renewed as of 01/01/24.





# **Lupin Lodge Near Santa Cruz is Up for Sale as Owner Retires**

We received the following email on 10/23/23

Dear Friends of Lupin Lodge,

In this letter, I would like to directly share with you upcoming changes for the Lupin Lodge club and to avoid rumors. It is with a heavy heart and with much consideration and many sleepless nights that I must announce to you my upcoming retirement from Lupin Lodge.

I have been a member of Lupin for 41 years. I have managed Lupin Lodge myself for the last 18 years. When I first took over from Glyn, I thought I would be doing this for just three years. Since Glyn's passing in November of 2015, I have been solely responsible for the management of the club and Lupin property with an ever-increasing workload. I have put in long working hours, often 24/7 for nearly two decades. Managing Lupin has been often so intense that I needed to back-burner my successful art career.

It is time now to retire, take better care of myself, and focus my efforts on my highest priority, the health of my family. After some eye-opening meetings with my cardiologist, I realized that I need to consider my health first and foremost.

With my retirement, the Lupin Lodge Club and the property on which we operate will go up for sale. The listing of the property will take place within a few weeks. Lupin Lodge is a separate entity and could be preserved on this property or another depending on the individuals who are involved.

It is with all my heart that I wish for Lupin Lodge to continue without me. We have a former member and neighbor with extensive business experience who is willing to invest seven figures in the effort to continue Lupin. He is looking for additional investors to help.

There are several other options that I have thought of and probably many more. Our team involved with the sale would favor a bid for the property or separately the club by a potential consortium of Friends of Lupin. That could be a co-op or other naturist entity, landed or non-landed.

Please understand that continuing Lupin on this property would face many challenges, including significant increases in taxes, insurance, compliance with new regulations, ADA, disability upgrades, septic upgrades, and other deferred maintenance. Keeping Lupin compliant could require millions of dollars beyond a purchase. However, the wealth of the Bay Area is considerable, and we might find these backers.

Our sister club, Sequoians in Castro Valley, established in 1947, still operates as a co-op. I have great respect for the Sequoians. Friends of Lupin might consider application for Sequoians membership https://sequoians.com.

My late husband Glyn always insisted that I put family first and that is what I intend to do. I have also promised myself to pursue my art career again as my health permits. I have given my very best to Lupin day by day over the decades and it is now time to pass the baton.

I realize that this change is disruptive for many of us. I truly hope that you will support this change and find a way to continue supporting the Lupin that we all love.

In a supplemental FAQ, Lori added: (edited here for space):

- "I plan to retire and move when the property is sold...I have not decided on the location. My health and my family's health come first and foremost."
- Current Lupin memberships will remain unchanged until the end of the year. After that members may choose to transfer to The Sequoians Club, located in the East Bay's Castro Valley.
- \$32,800,000 is the opening listing price for the property. She hopes to sell it to someone who will continue its clothing-optional tradition.
- Transferring ownership to her daughters is not an option as "they are at college building their own futures."

### **Uproar In Wisconsin Over Nude Child In World Naked Bike Ride**

The World Naked Bike Ride (WNBR) has been held in various cities worldwide for over 20 years, with Wisconsin's inaugural ride taking place in 2010. The event's organizers present it as a means to promote positive body image and encourage cycling—an environmentally friendly form of transportation that reduces the reliance on fossil fuels.

#### **BACKGROUND**

About 150 people participated in the June 17 World Naked Bike Ride, now in its 13th year in Madison. Their route included State Street and two loops around Capitol Square. Also staged in other cities around the country, the ride is aimed at encouraging bodyimage positivity and reducing dependency on petroleum.

But Wisconsin is a state in deep political turmoil with a veto-proof GOP majority in both legislative houses opposing the Democrat governor and a newly elected liberal majority on the state supreme court.

In July, two GOP state senators had received complaints about the bike ride, citing a photo of a girl, "younger than 10 years old," riding with her mother at the event. According to later reports, the mother had asked her daughter if she wanted to participate. She said yes, and she decided to ride naked. The mother claimed that her daughter enjoyed the experience and that she still asks when they're going to do it again.

After the event, Dane County Supervisor Jeff Weigand of Marshall said he filed an online report about the incident with Madison police after a county resident sent all County Board members an email about the girl.

The concerns of this lawmaker had gone nowhere as the Madison City Council had enacted an ordinance allowing nudity as a legally protected form of "political protest." The department's Special Victims Unit was assigned to the case and detectives "looked at the state's statutes on possession of child pornography and exposing a child to harmful material or narrations," but that "based on the image observed and city-sanctioned event status of the bike ride, it was determined at this time that neither statutes are applicable.

In an email to the Mount Horeb resident a few days after the race, Madison World Naked Bike Ride organizer Peter Keating said the participation of children in the event is "not an issue at all" and that "it has always been our position that minors are perfectly welcome to participate as they please, as long as they are accompanied by parent or legal guardian."

#### WHAT HAPPENED NEXT

In response, two state senators introduced two bills that will badly impact nude recreation:

**SB 477** - This bill prohibits a person from causing a person who is under the age of 18 to attend an event at which a group of adult participants intentionally expose their genitals, buttocks, or other intimate parts in a public area. The bill also prohibits taking a picture or other representation of a child at such an event if the representation depicts the child's intentionally exposed genitals, buttocks, or other intimate parts.

**SB** 478 - Current law prohibits a person from publicly and indecently exposing genitals or public areas. It would label the exposure of a naked body in a public place, regardless of intent, as a misdemeanor offense. Presently, public exposure is only considered illegal if it is deemed indecent. Violators could face up to nine months in jail and a monetary fine of \$10,000.

Republican Senate Senator Chris Kapenga, who introduced the bill said, "This is nothing to laugh at. The public exposure of genitalia should not be allowed."

Supervisor Weigand added "When you take your nudity into the public square, you're actually violating my rights... and my children's rights to not want to see that. That's where it crosses the line...We need to protect our children."

Republicans, who are now making this a campaign issue, have fast-tracked committee hearings, although as of our newsletter deadline, no committee votes have been taken yet. Both AANR and the Naturist Action Committee have combined their resources and hired a lobbyist to speak on their behalf and to try to amend the bills if they cannot kill them outright in committee.

Wisconsin's Democratic Party has voiced opposition to the proposed regulations, making it a partisan issue now. Sen. LaTonya Johnson (D-Milwaukee) voiced her concerns that the changes could mean parents would not be allowed to take children to a Beyoncé concert, for example, where dancers may show their buttocks on stage.

# CA Gov Signs Bill To Curb Online Child Sexual Abuse

10/9/23 - SACRAMENTO, CA - California Governor Gavin Newsom has signed AB 1394, effective January 1, 2025, a bill that will punish social media platforms like Facebook, Instagram and Tik-Tok for "knowingly facilitating, aiding, or abetting commercial sexual exploitation" of children. It also requires social media platforms to have a method for people to report child sexual abuse material for blocking. Fines could run up to \$4 million, depending on the circumstances.

Opponents said that it would have a "chilling effect" on free speech because tech platforms might delete more lawful content or disable popular features. Opponents included the California Chamber of Commerce, the Civil Justice Association of California, and several tech lobbyists, but the bill passed the State Assembly 77-0 and the State Senate 38-0.

Nudist websites and platforms might be affected if they need to defend against unjust child exploitation complaints or compliance challenges.

America to sign it! All you need to be is a person who believes we have the right to a small stretch of cand to enjoy the beach away from everyone else, no different than if we were asking for a dog park or a public tennis court for a hiking trail.
